

Participants Agreement, Release, and Acknowledgement of Risk

In consideration of the services of LakeRider Sports, LLC., its owner, employees, agents, volunteers, participants, and all other persons or entities acting in any capacity on their behalf, (hereinafter collectively referred to as "LakeRider"), I hereby agree to release and discharge LakeRider on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that kayaking, biking, paddle boarding, wakeboarding, wake surfing, kite boarding, wind surfing, sailing, row boating, paddle boating, bike trailers, knee boarding, water skiing, wake skating, inner tubing, motor boating, skate boarding, long boarding, mountain boarding, playing volley ball or tennis, snowboarding, kahuna stick rentals and snow skiing entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. 2. I understand, agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless LakeRider Sports LLC., its owners, employees, agents, volunteers, participants, and all other persons or entities acting in any capacity on their behalf from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of "LakeRider's" equipment or facilities, including all such claims which allege negligent acts or omissions of "LakeRider."
4. Should LakeRider, or anyone acting on their behalf, incur attorney's fees and costs to enforce this agreement; I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover injury or damage I may cause or suffer while participating, or else I agree to bear all costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume and bear the cost of all risks that may be created directly or indirectly by such condition.
6. I accept the full responsibility for care of equipment while in my possession. I will be responsible for the prompt replacement at full retail value of all rental equipment not returned or damaged. I agree to return rental equipment by agreed date and time in clean condition to avoid additional charges.
